**Anyone who has an obligation** but not an entitlement to attend the course must pay the course fee themselves. Such persons are obliged to complete a total of 300 hours of training in Norwegian and social studies. Section 17.3 of the Introduction Act

Participants not covered by a scheme. Anyone waiting for a decision from the Directorate of Immigration and Diversity (IMDi) must pay the course fee on the date of the decision and the decision is registered in NIR. Only when you have received an 'entitlement and obligation decision' for 600 hours will the hours start to count and the training be free.

You must inform the school of any change in the basis for your residence. If you are no longer able to attend the course due to prolonged illness, you must give written notice and present a medical certificate.

Expenses for books and Norwegian examinations are in addition to the course fee. A curriculum list will be distributed at the start of the course.

Once you have accepted the place, the agreement will be binding. The course fee can be paid by Visa card at the reception at the start of the course.

Places are subject to the availability of places on the course concerned and enough students registering to enable the course to be held. You will receive a reply to your application by e-mail or telephone.

We store your personal information in our systems as long as you are a student/participant at the school. The information is secured, and only those who need the information can access it.

Information worthy of permanent preservation will be processed and kept in accordance to the Archive Act.
